Commissioner Monahan asked if the long grass issue at Mays Park was taken care. Mr. Biondo reported that the operations staff mulched the area in question. - Commissioner Lee commented that the Smith House opening went very well. He congratulated the program staff on a job well done. Continuously improve focus on the community.

- Online enrollment up from 66% at this time last year to 81% for 2015.
- In the spirit of Halloween, Crafting Club welcomed a professional artist from Kettering's Rosewood Arts Center last week to instruct Zombie Drawing



- Fairy and Gnome Home Festival Approximately 130 people attended
- Haunted Trail October 21 and 22, Grant Park
- October Pop-Up Program *Dressed to the (K)Nines* at the Oak Grove Dog Park on Oct. 31 food trucks, red carpet, treats and more
- Luminary Walk will be held at Forest Field and Bill Yeck Park this year, incorporating the Smith House Dec. 11
- The Centerville Wee Elks regular season ends Oct 10/11. Tournament games will be played at Schoolhouse Park on consecutive weekends beginning October 17.
- Fall baseball games are complete. However, there are still numerous field reservations for tryouts, scrimmages and practices throughout the month.



- Initial grading and reseeding is complete for the Oak Grove Dog Park Improvements. Fence installation will begin Oct. 12.
- Post season athletic field maintenance is in progress. Work includes- aerating, fertilizing, and over-seeding
 the bare or worn turf areas as well as backstop repairs. Soil amendment was added to the skinned areas at OG
 and SH parks to improve playing conditions next spring.

Ensure sound long-term financial viability.

- The Activity Center Trail doesn't connect regional trails/pathways so it doesn't qualify for Clean Ohio Grants. The trail could be eligible for the Recreational Trails Program Fund next year.
- **Internet Auction**. The remaining few pieces of obsolete equipment will be placed on GovDeals later this month. Items include: 2- John Deere utility mowers, and 1- Chevy S-10 compact pick-up truck. (b)

- **Safety Team Update.** Grant George attended this month's Safety Workshop **A.L.I.C.E.** Alert, Lockdown, Inform, Counter, and Evacuate. The training covered a comprehensive preparedness program for a violent intruder event.

Provide leadership to the community in open space preservation and environmental management

• **Pond Management.** Completed a fish population study at Oak Grove Park. Eric Lykins supervised the project, which also enlisted assistance from the students from the CHS Environmental Management Program. The students collected water quality data from the pond. A report based on the data collected will be used to develop future management and stocking recommendations for the pond. (a)

- Self-Closing hinges will be added to the door before the restroom is fully open to the public.

- Nursery's will begin digging trees for fall plantings around the middle of October.
