## VI. BUSINESS

# A. Revised Appropriation Budget - Resolution 2019-07

The Purchase Order approved at the 11/12/2018 meeting for \$360,000 to O'Heil Site Solutions (Oak Grove Restroom Project) was not encumbered in 2018. This amount was also not included in the 2019 Budget. In order to move forward, the Board will need to approve Resolution 2019-07, increasing the budget.



Commissioner Lee moved, Commissioner Sanchez seconded, to adopt Resolution 2019-07, the 2019 Revised Appropriation Budget. The Board further authorized President Sanchez to sign the Resolution. A copy is attached to and made a part of these minutes.

B. St. Leonard Easement – As of this writing, St. Leonard had not completed their review. However, correspondence from the CEO verified that it was received and should not take long for their review and signing. Their only stipulation is that the trail be built on the south of the stream and that they would be able to build bridges as originally planned and agreed upon. The two bridges are specifically addressed in the Easement contract. The location of the trail is not. Staff and Board Attorney added language specifying the trail would be located on the south side.

Commissioner Monahan moved, Commissioner Sanchez seconded, to ratify the Conservation Easement agreement with St. Leonard of Centerville, Ohio, pursuant to Ohio Revised Code applicable sections.

# C. Withdrawal from 1993 Memorandum of Understanding

Commissioner Monahan moved, Commissioner Sanchez seconded, to exercise the option described in Paragraph E of the 1993 Memorandum of Understanding with Washington Township, to give notice to not automatically renew the M.O.U.
