

Regular Meeting Minutes

September 04, 2019

I. CALL TO ORDER

A regular meeting of the Board of Park Commissioners of the Washington Township Park District, also known as the Centerville-Washington Park District, was held at the Park Operations Facility. Approval of Financial and Investment Activities

Commissioner Sanchez moved, Commissioner Monahan seconded, to authorize the August 2019 financial and investment activities. Commissioners Lee, Monahan and Sanchez: ayes, motion carried.

VI. BUSINESS

1. Grant Park Stream Restoration Project

Construction bids opened on Tuesday, September 3. The scope of work was reviewed and slightly modified to get within budget projection and engineer's estimate.

Commissioner Sanchez moved, Commissioner Monahan seconded, to award a contract to Evans Demolition/Site Development/Landscaping for the trail and shoreline restoration at Grant Park in the amount of \$185,149 and a 5% contingency. Commissioners Lee, Monahan and Sanchez: ayes, motion carried.

2. Stewardship Policy

The third draft of the Policy was presented to the Board and included the following changes (at the Board's request):

- 1. Showing the first priority being environmental benefit
- 2. Acknowledging the need to conduct cost-to-benefit analysis
- 3. Giving Board more leeway and flexibility in deciding how much of a new or renovated park will be in native plants

Commissioner Sanchez moved, and the Board unanimously agreed, to adopt the Stewardship Policy, effective immediately.

3. Change Order for Activity Center Rehab Project

Staff reviewed the recent discovery during construction of the community program room. It was determined when cutting for doors and windows that the existing board and batten strips had no plywood sheathing or waterproof membrane. This would leave the building with many areas where water could seep into the building, not only voiding warranties, but causing damage to the interior.

To adequately protect the building and the investment, plywood sheathing and waterproofing must be installed. Then, install new maintenance-free siding that will last for many years.

Commissioner Lee moved, Commissioner Sanchez seconded, to authorize up to \$50,000 for additional expense of underlayment and siding for Activity Center building.
