# Centerville Rec Soccer Operations Proposal Fall 2020

Centerville Rec Soccer will take precautionary measures to defend against the spread of Covid-19 by implementing guidelines as directed by the Ohio Dept of Health (ODH), Centers for Disease Control (CDC), and Centerville-Washington Township Parks District (CWPD). We will conduct ourselves in accordance with these organizations, and maintain HIPPA regulations regarding any potential illness. Centerville Rec Soccer are dedicated to providing a safe, family friendly program to our soccer families, and to maintain the guidelines as instructed.

## **Social Distancing**

- Spectators will be asked to not attend any activities if they have any COVID-19 symptomology, or have been exposed to anyone diagnosed with COVID-19
- No congregating by spectators in the parking lot or on the sidelines. We will ask that spectators read the signage and make any inquiries regarding safety at the soccer fields
- Spectators will be encouraged to limit the number of family members and friends from attending the training
- Mask will be worn by spectators on the sidelines, except those immediate family members allowed to sit together. 6' separation between families is required. We will ask that spectators do not smoke, and to move away from others and cover their face if coughing or sneezing
- Spectators will maintain appropriate distance of 6' between seating groups of immediate families on and off the field
- Players will be required to maintain distance on the sidelines, and wear a mask if they cannot maintain 6' separation when on the sidelines
- If players arrive early, they are to remain in their vehicles until instructed to join the trainers
- A brief safety meeting will be conducted regarding the rules and regulations with regards to COVID-19, requiring players maintain distance on the sidelines, and to sanitize their hands prior to playing, and to refrain from touching their face while participating
- Training will be staggered in timing to allow families to safely enter and exit the facility with distance between all parties attending
- Spectators will be requested to leave in staggard order to allow for social distancing

### **Sanitation**

- Hand sanitizer stations will be set-up at the entrance to the field areas
- Board members/volunteers will stand at the sanitizer stations with disposable gloves on to perform sanitizing duties
- Hand sanitizer stations will be used by players and trainers as they enter the field
- Equipment will be cleaned and sanitized between sessions, and whenever possible in the course of play
- Restrooms will be cleaned prior to and after each session to maintain safety and sanitation of the area

#### **Enforcement of Rules**

- A compliance officer (board member of Centerville Rec Soccer) along with any attending or
  participating Centerville Rec Soccer Board Members will implement the proper sanitation of
  players, equipment, trainers and restrooms in the course of attendance at Oak Grove Park. The
  compliance officer will also monitor the fields for spectators and players maintaining social
  distancing and protocol to maintain safety.
- Each age group will only participate in 1 session in a 24-hour period, to enable decreased exposure, and allow for contact tracing if necessary

## **Education of Players, Attendees & Trainers**

- Prior to the start of the season, the Compliance Officer, volunteers and board members who will be attending sessions will undergo an outline of the education as instructed by the ODH.
- Trainers will review hygiene, social distancing, signs and symptoms of illness and safely coughing or sneezing with the players prior to each session
- An announcement will be made to spectators at each session, with reminders of the instructions by the ODH, and maintaining safety while at the fields, as well as no congregating in the parking lot while coming and going from sessions

## **Suspected or Diagnosed Cases**

- Any person, whether they are a player, trainer, board member, or spectator showing any
  symptoms of COVID-19 will be immediately removed (per CDC directives), and leave the
  premises. Contact with their physician or immediate medical care, and anyone who was directly
  exposed will also have to undergo the guidelines for anyone with COVID-19 exposure in
  accordance with the ODH and CDC.
- Any players with a household member who tests positive must quarantine according to the guidelines of the ODH and/or CDC, prior to return to play
- Any player who tests positive will be removed from participation until instructed it is safe to
  participate, and any other players, trainers, board members or spectators will be notified if
  knowledge of close proximity is present, while maintaining HIPPA guidelines regarding the
  identity of the person
