## CUSA Covid-19 Management Protocol

- The main compliance officer is Patrick King, Executive Director of CUSA Soccer Club.
  - Due to the nature of this organization and the multiple events that it participates in across the course of any given week, CUSA will also need to delegate this to 'sub compliance' officers on certain occasions, not limited to game days and practice days.
    - It will not necessarily be possible to supply the names of these 'sub compliance officers' ahead of time.
- The Park's Department has yet to provide us with signage but when they do, we will draw people's attention to them through internal communication.
- All members of CUSA, coaches, players and parents have been notified of the State order. Furthermore, they have also been provided with the summary to this order as well as further clarification from this organization itself, a copy of which was also sent to the Park's Department.
- Hand sanitizer stations will be provided during games and practices.
  - Participants and observers will be asked to take regular advantage of hand sanitizers.
- CUSA will send a copy of this plan, the statewide order, the summary to the order as well as the CUSA clarification to all opponents travelling to our home fields at Oak Grove ahead of time 'know before you go'.
- All game times and dates will be communicated to the Park's department, the liaison being Renee Post who will communicate this through the use of the 'Master Google Sheet' used by Jason Beavon at the Parks Department.
- Kick-off times will be appropriately spaced to allow enough time for teams to move in and out after games (two hours between consecutive kick off times)
- CUSA practice times will be staggered to allow the entry and exit of players, families and coaches to and from Forest Field, with the minimum of overlap. As of Tuesday, September 8<sup>th</sup>, these times will be 5pm to 6.20pm and 6.40 to 8pm Monday through Friday.
  - CUSA has sub-programs (recreational soccer, Sports Metrics etc.) which do not run on the same schedule as our regular Select programs and we will internally manage these start and finish times as best as we can in order to align them with the mass foot traffic created by the Select program.
  - A foot traffic directional flow has been designed and posted up on our website, as well as being communicated internally to all CUSA participants and staff to help minimize contact between people at Forest Field.
- Families must sit together and will be asked to observe the six-foot minimum social distancing rules at all times.
- Spectators will be required to conduct daily wellness/symptoms checks and told to stay home if feeling unwell and showing symptoms.
  - At-risk spectators will be asked to stay home.
- Families will be asked to wear facemasks.

- Coaches are asked to wear facemasks whilst actively coaching if possible, and certainly whilst being present at a facility and not actively coaching.
- The Parks Department have indicated that they may reach out to us for sanitization issues outside of their working hours.
- No congregating before or after games.
  - Family members will be asked to remain in their cars before kick-off (during warmups) and once the final whistle has been blown.
- Lindsay's Law and associated information is communicated to coaches and staff whilst completing their background checks which was completed by all staff within the last few months.
- All families, coaches and staff have been sent the educational videos and the 'infographics' from the Ohio Department of health, these are also hosted on our website [www.cusasoccer.org/covid-19-protocol](http://www.cusasoccer.org/covid-19-protocol)
