A. Approval of Financial and Investment Activity

Commissioner Sanchez moved, Commissioner Monahan seconded, to authorize the December 2020 financial and investment activity. Commissioners Pearl, Monahan and Sánchez: ayes, motion carried.

III. BUSINESS

A. 2021 Final Budget, Resolution 2021-01

Commissioner Monahan moved, Commissioner Pearl seconded, to approve Resolution 2021-01, the 2021 Preliminary Appropriation Budget. A copy is attached to and made a part of these minutes. Commissioners Pearl, Monahan and Sánchez: ayes, motion carried.

B. 2021 Hylant Invoice

This invoice was received after the December Board meeting. It requires Board approval, due to the amount.

Commissioner Pearl moved, Commissioner Monahan seconded, to approve the 2021 Hylant invoice for Property, Liability and Casualty Insurance. Commissioners Pearl, Monahan and Sánchez: ayes, motion carried.

C. Purchase Orders

To make requisition and purchase order requests more efficient, staff would like to request approval of the following purchase orders, which should cover most of 2021 expenditures for the vendors.

- Dayton Power & Light \$55,000
- Hylant \$31,000
- Medical Mutual Insurance \$330,000
- Montgomery County Water \$35,000
- OPERS \$280,000
- Promotional Spring \$48,000
- Quanexus \$45,000

Commissioner Sanchez moved, Commissioner Pearl seconded, to approve 2021 purchase orders listed within the minutes. Commissioners Pearl, Monahan and Sánchez: ayes, motion carried.

D. FSA/HSA Plan Revision, Resolution 2021-02

In order for Business Manager Huff to make recommended changes to the FSA/HSA Plan documents, a resolution must first be passed acknowledging that she may sign documents. The suggested changes are summarized below:

- Unrestricted Carryover Employers can change their health and dependent care FSAs to allow carryover of all unused amounts from 2020 to 2021 and from 2021 to 2022.
- Allowances for Terminated Employees Health FSA participants who terminate their employment
 during the 2020 or 2021 plan year can spend down their unused balances for expenses incurred through
 the end of the plan year in which the termination occurred, including any grace period (similar to what
 has been previously permitted for dependent care amounts).



• Election Changes without Qualifying Status Events - Employers can permit prospective changes in election amounts for health and dependent care FSAs for plan years ending in 2021 without a corresponding change in status event (similar to Notice 2020-29 released by the IRS in the early stages of the COVID outbreak).

Commissioner Monahan moved, Commissioner Sanchez seconded, to adopt Resolution 2021-02, allowing Business Manager Huff to authorize HSA and FSA plan changes. Commissioners Pearl, Monahan and Sánchez: ayes, motion carried.

E. Grant Park Master Plan

Discussion and adoption of Grant Park Master Plan.

Commissioner Sanchez moved, Commissioner Pearl seconded, to adopt the Grant Park Master Plan. Commissioners Pearl, Monahan and Sánchez: ayes, motion carried.
