A. Approval of Financial and Investment Activity

Commissioner Pearl moved, Commissioner Sanchez seconded, to authorize the October 2020 financial and investment activity. Commissioners Pearl, Monahan and Sánchez: ayes, motion carried.

VII. BUSINESS

A. 2021 Health Insurance

One insurance companies have provided quotes to our broker. The information is brief, but telling:

- Current provider, Medical Mutual of Ohio: 5.1% for Health Savings Account; 10.5% for PPO
- Previous Provider, Anthem, for same type of insurance product: 49% higher than current premiums
- United Health Care has not submitted a quote, but broker expects it to be close to Medical Mutual
- Aetna, no quote yet.
- Broker asked for all quotes to be submitted by Nov. 4, in time for this Board meeting

Staff suggested two options to suggest to the Board. First, Option A, to approve a dollar amount, but not the company. The dollar amount calculated is the 2020 budget, increased by the quoted increases. Because employees might want to switch coverages, staff added a small contingency to arrive at an estimated budget of \$330,000.

The second option was to wait until another quote arrives, and call a special meeting. That meeting would have to have been no later than November 23 as open enrollment begins the following week.



As a reminder, when premiums increase, the percent increase is applied to both the employee and CWPD portions.

Commissioner Sanchez moved, Commissioner Monahan seconded, to budget \$330,000 for the 2021 health insurance policy. Commissioners Pearl, Monahan and Sánchez: ayes, motion carried.

B. Fall Tree Planting

Annual tree planting takes place each fall to replace dead, diseased, or dying trees located in high visible park locations. Additionally, trees will be planted in recently developed park areas, and through monetary donations received for the tree dedication program. The approved budget for 2020 is \$40,000. Staff received three quotes from local nurseries for approximately 200 trees of various species. Due to the limited availability of nursery stock, none of the three nurseries was able to fulfill the entire order. For this reason, staff is proposing to break the full order up between the two nurseries that had the best pricing and availability. Although the two separate quotes fall below the amount that requires board approval, the total of both are \$32,000. The total is below Ohio's public bid threshold.

Commissioner Monahan moved, Commissioner Pearly seconded, to approve the total purchase of \$32,000 of trees for fall planting in various parks. Commissioners Pearl, Monahan and Sánchez: ayes, motion carried.

C. CIP Proposed 2021 Budget Review

Formal vote is not necessary. Adding the CIP budget to the Fiscal Year 2021 Budget may be approved by consensus of the Board. Any additional discussion and agreed-upon edits may occur during this part of the meeting. Only the projects and accompanying amounts for 2021 are included in FY 2021 Preliminary Budget, for Board approval in December.

D. Salary and Wages for Fiscal Year 2021

Looking toward the December preliminary budget presentation, the Board will see a wage and salary increase in-line with the national trends. The information used is noted below. The budget is being constructed with a 3% pool, unless the Board requests a different figure. (CWPD salary and wage pool in 2020: 3%)

- Actual U.S. average salary and wage increases in 2020: 2.9% (source www.shrm.org)
- SHRM 2021 projection: 2.9%
- Salary.com projection: 3.0%
