# A. Approval of Financial and Investment Activity

Commissioner Pearl moved, Commissioner Senney seconded, to authorize the July 2021 financial and investment activity. Commissioners Monahan, Pearl and Senney: ayes, motion carried.

### VI. BUSINESS

# A. Yankee Park Playground Optimist Add-on

The Board approved purchases (not to exceed \$290,000) for Yankee Park playground updates at the

July 12, 2021 meeting. Since that time, Centerville Noon Optimists have committed to donating \$25,000 to be used toward the playground. The donation will be paid directly to the District, and inclusive features and shade have been added to the design. As such, staff requests that the Board approved a revised purchase order amount.

Commissioner Pearl moved, Commissioner Senney seconded, to award the Yankee Park playground Equipment, shade structure and safety surface contracts to Penchura LLC and Landscape Structures for a combined (purchase order) total not to exceed \$315,000. This shall replace the motion/approval, for the same project, from the July 12, 2021 Board meeting. Commissioners Monahan, Pearl and Senney: ayes, motion carried.

# B. Playground Equipment Purchase

Staff is requesting PO and contract approval for budgeted playground (equipment) enhancements at Black Oak, Donnybrook, Quail Run, and Willowbrook Parks. All companies presented participate in the joint purchasing program, approved by the State of Ohio, to satisfy competitive bid pricing requirements.

- Willowbrook Park proposal is \$56,692.00 (Playworld Midstates) for new playground structure and amenities.
- Black Oak, Donnybrook, and Quail Run Parks proposal is \$59,889.76(Penchura and Landscape Structures) for replacing old parts and equipment along with new playground amenities.

Commissioner Pearl moved, Commissioner Senney seconded, to approve a purchase order and contract for \$57,000 to Playworld Midstates for the installation of new playground equipment at Willowbrook Park. Commissioners Monahan, Pearl and Senney: ayes, motion carried.

Commissioner Pearl moved, Commissioner Senney seconded, to approve purchase orders and contracts for \$60,000 to Penchura and Landscape Structures for the installation of new playground equipment and repair of existing worn parts at Black Oak, Donnybrook, and Quail Run Parks. Commissioners Monahan, Pearl and Senney: ayes, motion carried.

# C. Holes Creek Park Streambank Restoration

Streambank erosion is threatening the paved trail system in the park. Four proposals for mitigation efforts were received, with the project scope addressing three high priority locations. Channel Maintenance Systems, LLC. submitted the best, lowest, and most responsive proposal for \$28.800. Staff recommends a purchase order for (2021 budgeted amount) \$42,500. This will allow additional restoration efforts outside the original scope of the project, if identified.



Commissioner Senney moved, Commissioner Pearl seconded, to approve a purchase order and contract with Channel Maintenance Systems, LLC., in the amount of \$42,500, for streambank restoration at Holes Creek Park. Commissioners Monahan, Pearl and Senney: ayes, motion carried.
