#### A. Tax Year 2020 Amounts & Rates Resolution

Ninety-five percent (95%) of the estimated revenue for tax year 2021 (budget year 2022), as provided by the Montgomery County Auditor, is \$4,957,057. A resolution must be passed acknowledging this amount, per ORC 5705.34-5705.35.

Commissioner Pearl moved, Commissioner Monahan seconded, to accept Resolution 2021-10, authorizing the amounts and rates as determined by the budget commission and authorizing the necessary tax levies and certifying them to the County Auditor. Commissioners Monahan, Pearl and Senney: ayes, motion carried.

In an effort to make sure that the background screen policy is up-to-date, Business Manager, Chris Huff, reviewed and edited the policy, and had legal counsel and the background screening company review.
