

Sprayground Group Visitor Information

Thank you for interest in reserving a date for your group to visit the sprayground at Activity Center Park.

Due to the popularity of the sprayground and to ensure an enjoyable experience for all, please complete the Sprayground Group Visit Request Form prior to your visit.

The group shelter, located next to the sprayground, can be reserved for a nominal fee for up to 30 people. Please note that only a portion of the shelter is reserved at any given time, the other half will be open to other guests visiting the park. If you would like to reserve the shelter, please call us at (937) 433-5155. Other areas in the park with picnic tables are available for groups to gather on a first-come, first-served basis.

When a completed form is received, we will contact you with a confirmation or ask for additional dates. Due to the large number of requests, **sprayground group visits are limited to three during the summer at a maximum of three hours per visit.**

The sprayground will be open to the general public during your visit, please be respectful of their needs.

Recommendations

- Review sprayground rules with your children.
- Actively supervise your children.
- Provide at least two adults for every 15 children.
- Avoid bringing valuables as we are not responsible for lost or stolen items.
- Feel free to bring sports or game equipment to enjoy in other areas of the park.
- Bring plenty of sunscreen and towels.
- Bring drinks in plastic containers only.
- To avoid slipping, water shoes are recommended.
- To activate the spray features, walk past the red bollard.
- Weather can change quickly. Be prepared to take cover if thunder or lightning are present.

Sprayground Rules

- This is an unsupervised sprayground. The use of this facility is strictly at your own risk. (ORC 2744) The Centerville-Washington Park District does not assume any responsibility for loss or injuries. Adult supervision for children under 12 is recommended. Actively supervise your children.
- To avoid slipping, water shoes are recommended.
- Do not use sprayground if you have diarrhea.
- Water is not meant for drinking.
- Take regular restroom breaks.
- Wash hands after using the restroom or changing diapers.
- Do not change diapers on the sprayground pad.
- Children not potty-trained must wear swim diaper.
- No pets, bicycles, scooters, skates or skateboards.
- No food, drink or glass containers permitted within 50 feet.
- No running, jumping, climbing or throwing objects.
- Groups of 10 or more must schedule their visit with the Park District.
- Seek shelter for lightning and thunder.
- Open seasonally from 8:30 a.m. – 8:30 p.m., 7 days week, Memorial Day weekend through Labor Day.
