Commissioner Senney moved, Commissioner Pearl seconded, to authorize the September 2023 financial and investment activity.

VI. BUSINESS

A. Fleet Replacement Purchase Order

In anticipation of scheduled fleet replacement needs for 2024, staff has received government pricing from Kings Ford to purchase one F-250 Ford pickup truck. The truck's purchase price is above the Executive Director's approval limit and is being brought to the Board for approval. A purchase order is required to place an order for delivery and payment in 2024. The new truck will replace truck #17, 2008 Ford F-250 with 85,526 miles. Truck replacement is based on 12 years and over 70,000 miles, or over 100,000 miles.

Commissioner Pearl moved, Commissioner Senney seconded, to authorize the purchase order for \$50,000 to Kings Ford Dealership for the purchase of a fleet truck.

B. Grant Resolution - Land and Water Conservation Funding Resolution 2023-16

This is the standard action that allows the Park District to apply for the grant. It is intended that the District will apply to land a grant to offset costs related to renovation of the Sprayground at Activity Center Park. The resolution affirms that the District has funds to meet the grant's matching requirements.

Commissioner Senney moved, Commissioner Pearl seconded, to approve Resolution 2023-16.
