

The Centerville-Washington Park District delivers fun, healthy, and outstanding park experiences that connect the community to the outdoors. We hope to provide these experiences for all members of the Centerville and Washington Township community. Financial assistance is available for residents to participate in Park District programs. Qualifying families will receive \$50 in program credit per person in the household, maximum of \$300 per family, to help remove financial barriers to participation. Awards will be granted on the basis of demonstrated financial need.

To receive financial assistance from the Centerville-Washington Park District, the recipient must:

- Be a resident of Centerville or Washington Township.
- Have not submitted a request during the same calendar year.
- Complete the Financial Assistance Application on the next page, which includes most recent tax return or other documentation of income.
- Meet the income eligibility requirements listed below:

Financial Assistance Application

Financial assistance is available for citizens to participate in programs offered by the Centerville-Washington Park District. Financial assistance is awarded based on the following information:

- Completion of this application at least two weeks in advance of the start of the program.
- Written explanation of financial need.
- A copy of your most recent federal tax return or other documentation of income. Acceptable forms of documentation include W2 forms, pay stubs, Social Security statements or public assistance verification. A current Centerville City School free and reduced lunch program form can also serve as proof of income.
- Applicant must be a resident of Centerville or Washington Township.

Please note the following:

- Assistance is not transferable to other households.
- Funds do not roll over year to year. A family must reapply for funding each calendar year.
- In event of cancellation, any registration fees paid by the applicant will be refunded.
- Partial refunds will not be issued for programs that a participant is registered for prior to obtaining approval for financial assistance.
- Partial refunds will not be issued for programs participants attended prior to approval.
- Programs can sell out and you may be placed on a waitlist. Financial assistance will only be used if you get in the program.
